Michael Black (UT) welcomed all attendees to Utah.

#### **President's Report**

Craig Knowles (GA) introduced Ed Bolden (TN) for the President's Report.

Bolden spoke about his history with the TN Massage Board and the Federation and presented a summary of the work the Federation has done for its member boards in the last year. Bolden acknowledged and thanked past Board of Director Presidents, volunteers, staff, vendors, member boards, and fellow Board of Directors. He announced that a new MBLEx support center will be located at the FSMTB Headquarters in Overland Park, KS. Bolden reported on topics including the MBLEx, Job Task Survey, the Massage & Bodywork Licensing Examination Study Guide, the Executive Directors' Summit, Education Record Center, Massage Therapy Licensing Database, and the strategic plan. He also addressed his vision of the future.

Bolden introduced Jamie Corey (PA), Chair of the Policy Committee, to provide the Policy Committee's recommendations on the resolutions and bylaws amendments.

Bolden recessed the meeting for a break at 9:30 AM MT.

The meeting reconvened at 10:15 AM MT.

## Presentation of the Slate Candidates for the FSMTB Board of Directors

Bolden introduced Charlene Russell (MS), Lydia Nixon (FL), Pam Nichols (GA), and Bridget Myers (ND).

Nixon indicated the role of the nominating committee, per the bylaws and introduced the slate of candidates. The candidates gave a short speech regarding why they are seeking election to the Board of Directors.

Seat 2: Dianne Layden (NC), Ahmos Natanel (CA), and Keith Warren (AL)

Seat 3: Victoria Drago (FL) and Caroline Guerin (TX)

Russell asked the candidates to each draw one question and provided them each with one minute to respond.

Russell thanked the candidates and the committee before turning the meeting over to President Bolden.

### **Treasurer's Report**

Bolden introduced David Cox, Treasurer, member of FSMTB Board of Directors and Chair of the Maryland Board of Massage Therapy Examiners, to provide the Treasurer's Report.

Cox introduced and thanked the finance committee: Paul Andrews (MA), Micheal Black (UT), Kate Coffey (OR), Keith Warren (AL), and AJ Groeber (OH).



Cox reported that FSMTB had a \$635,000 surplus and the FSMTB received a very good audit report with no significant findings. He explained how one of the examples of growing and sustaining the FSMTB infrastructure is looking at how to bring all exam application processing in-house instead of outsourcing.

Cox stated "FSMTB has had a strong year financially we have several projects that will require significant funding. Any profit is reinvested into FSMTB services to promote public protection. We remain diligent with spending your money and take our fiscal responsibility very seriously."

### **Member Board Reports**

The delegate from each FSMTB Member Board presented a summary of key regulatory initiatives and concerns in their state, for discussion of shared issues. Charlene Russell (Board of Directors) facilitated the discussion.

The CAMTC CEO, Ahmos Netanel, addressed the Delegate Assembly regarding Bill 1480 and responded to questions.

# **Human Trafficking and Massage Therapy**

Bolden introduced Tom Ryan (WI)

Ryan provided background information that the Human Trafficking Task Force resulted from a resolution brought forth by the Tennessee Massage Licensure Board. The FSMTB Human Trafficking Report was published in 2017. Ryan focused on the second charge that was asked of the task force – what the States are doing to combat human trafficking. Ryan introduced the two speakers, Kimberly Hodge, TN, and Beverly May, CA.

Hodge (TN) spoke about what the Tennessee Board is doing to help combat fraud, human trafficking, and prostitution.

Beverly May (CA) spoke about what the California Massage Therapy Council is doing to combat human trafficking and the tools they have available to help with the fight.

Ryan posed questions to the delegate assembly regarding what can be done to help combat human trafficking.

## **Elections**

Bolden (TN) introduced the tellers and turned the meeting over to Charlene Russell (MS). Russell reviewed the names of those on the slate of candidates.



While the votes were being tallied, David Cox (MD) provided recognition and appreciation to the members of the 2018 Nominating Committee (Lydia Nixon, Bridget Myers and Pam Nichols) and the members of the Board of Directors who had completed their term of service (Ed Bolden, Craig Knowles and Linda Lyter).

Election results for the Board of Directors.

Craig Knowles (GA) and Victoria Drago (FL) were elected to the Board of Directors.

There was not a majority vote for Seat 2. A runoff election between Ahmos Netanel (CA) and Dianne Layden (NC) occurred. Dianne Layden (NC) was elected by majority vote of the delegate assembly.

Bolden opened the floor for nomination of candidates for the 2019 Nominating Committee.

- Lydia Nixon (FL) was nominated by the 2018 Nominating Committee.
- Micheal Black (UT) nominated himself.
- Pam Nichols (GA) nominated herself.
- Jan Shaw (NC) nominated Bridget Myers (SD).

Nominations were closed. Ballots were distributed and collected from the delegate assembly.

Knowles (GA) expressed appreciation to host state Utah, the furthest who traveled, Puerto Rico and Alaska, and the states who put forth resolutions, Georgia, Oregon, and Wisconsin.

There was a 10-minute break while the votes were tallied.

Lydia Nixon (FL), Micheal Black (UT), and Bridget Myers (SD) were elected to the 2019 Nominating Committee.

## **Voting on Resolutions and Bylaws Amendments Submitted by Members**

 Resolution 1: "Formation of a FSMTB Task Force to review the numerical versus pass/fail score reporting system for massage therapy candidates for licensure" – Georgia

The meeting recessed for a break and reconvened at 11:15 AM MT.

## The State of Massage Education

Kevin Snedden, FSMTB Director of Professional Standards was introduced. Snedden provided a summary of the Massage Education Policy and the education verification prior to the July 1, 2017 policy. He explained how the policy and Education Record Center resulted from the work of committees and task forces. Snedden shared the positive impacts of the policy and discussed challenges.

Snedden introduced a panel comprised of regulators and school administrators: Emmanuel Bistas (IL), Darlene Campo (WI), Nancy Harrell (NC) and Dawn Hogue (VA).

Panelists spoke about being approached by a fraudulent school to provide transcripts for several individuals and addressed who governs schools in their states, challenges with different agencies and challenges with approvals for out-of-state schools.

Snedden thanked the panelists for their preparation and participation.

The meeting was recessed for lunch at 12:04 PM MT.

The assembly reconvened at 1:08 PM MT

#### The Future of Regulation

Bolden introduced Dale Atkinson, FSMTB legal counsel.

Atkinson discussed the future of regulation. Topics included understanding the role of the board and the board member, ability to articulate such roles, forging relationship with legislature, being effective and efficient, avoiding parochialism, and leveraging a collective voice/FSMTB.

#### **FSMTB Strategic Plan**

In preparation for strategic planning, Bolden (TN) discussed the strategic objectives of the FSMTB. Bolden then facilitated a discussion with the membership regarding what members would like to see in the next decade and in the more immediate (four years) future.

Russell (MS) explained the optional roundtable discussions and the locations of each.

Topics were:

- A. Establishment Licensing
- B. Regulating Massage Where CBD Oil and Marijuana are Legal
- C. Sunset Reviews

Bolden (TN) thanked everyone for their attendance and participation.
